

Terms & Conditions

Instagram Giveaway – 4 Tickets for Red Bull Erzbergrodeo

Organized by Remus Innovation GmbH

1. Organizer

This Giveaway (the "Giveaway") is organized by **Remus Innovation GmbH** (hereinafter the "Organizer"), operating the Instagram account **@Remus_sportexhaust**.

The Giveaway is conducted in accordance with Austrian law, in particular the Act Against Unfair Competition (UWG) and the Austrian Data Protection Act (DSG) as well as the EU General Data Protection Regulation (GDPR).

2. Promotion Period

The Giveaway starts on the date of publication of the Giveaway post on the Instagram account @Remus_sportexhaust and ends **14 (fourteen) days after publication at 23:59 CET** (the "Closing Date"). The exact Closing Date will be stated in the caption of the Giveaway post. Entries submitted after the Closing Date will not be considered.

The Organizer reserves the right to extend, shorten, suspend or cancel the Giveaway at any time for important reasons, without any claims arising for participants.

3. Prize

The prize consists of **four (4) tickets to the Red Bull Erzbergrodeo 2026**, taking place in Eisenerz, Austria (the "Event"). Travel, accommodation, catering, transfers and any other expenses are **not included** and must be borne by the winner. The prize is **non-transferable**, cannot be exchanged and **cannot be paid out in cash**.

Entering the Giveaway does not create any legal claim against the Organizer. The Giveaway does not constitute a prize offer (*Auslobung*) within the meaning of Sections 860 et seq. of the Austrian Civil Code (ABGB).

4. Eligibility to Participate

Participation is open to natural persons who:

- are at least **18 years of age** at the time of entry;
- have a public Instagram account and comply with Instagram's terms of use;
- reside in Austria, Germany, Switzerland, Liechtenstein or another EU/EEA member state (shipping of tickets, if physical, is organized accordingly – otherwise tickets are provided digitally);
- fulfil all entry requirements set out in Section 5.

Excluded from participation are employees of the Organizer and its affiliated companies, their family members, as well as any person involved in the organization of the Giveaway. In the Event of a breach of these terms & conditions, the Organizer reserves the right to exclude participants from the Giveaway.

5. How to Enter

To enter the Giveaway, participants must cumulatively fulfil the following conditions within the promotion period:

- **Follow** the Instagram account **@Remus_sportexhaust**;
- **Like** the official Giveaway post and **tag at least 2 (two) friends** in the comments;
- **Share** the Giveaway post on their own Instagram Story.

Each participant may enter only once. Multiple accounts, fake accounts, bots, tagging of non-existent profiles or any form of manipulation will lead to exclusion. Entry is free of charge; no purchase is necessary.

6. Selection of the Winner

The winner will be determined by a random draw from all valid entries within 7 (seven) days after the end of the promotion period. The random draw will be conducted using a neutral and objective selection process. Legal recourse with regard to the determination of the winner is excluded.

7. Notification and Claim of Prize

The winner will be notified by the Organizer via a direct message (DM) on Instagram.

The winner must confirm acceptance of the prize and provide the data required for delivery (full name, e-mail address, and postal address if applicable) within **seven (7) days** of being notified. If the winner does not respond within this period, the claim to the prize lapses and a new winner will be drawn.

8. Data Protection

Personal data provided by participants (e.g. Instagram username, and – in the case of winning – name, e-mail and postal address) will be processed by the Organizer solely for the purpose of conducting the Giveaway and delivering the prize. The legal basis for this processing is Art. 6(1)(b) GDPR (performance of a contract / pre-contractual measures) and Art. 6(1)(f) GDPR (legitimate interest in conducting the Giveaway).

All personal data will be deleted no later than 3 (three) months after the end of the Giveaway, unless statutory retention obligations require longer storage. Data will not be passed on to third parties, except to service providers required for the delivery of the prize (e.g. ticketing partner, postal service). Participants have the right, at any time, to information, rectification, erasure, restriction of processing, data portability, objection, and the right to lodge a complaint with the Austrian Data Protection Authority

(Datenschutzbehörde, www.dsb.gv.at). Further information is available in the applicable Organizer's Privacy Policy (<https://remus.eu/de/privacy-statement>).

9. No Affiliation with Instagram / Meta

The Giveaway is in not sponsored, endorsed, administered by, or associated with Instagram or Meta Platforms Ireland Ltd. The recipient of the information provided by participants is **not** Instagram, but the Organizer.

Any questions, comments or complaints regarding the Giveaway must be directed to the Organizer and not to Instagram or Meta Platforms Ireland Ltd. Participants release Instagram and/or Meta Platforms Ireland Ltd from any liability in connection with the Giveaway.

10. No Affiliation with Red Bull / Erzbergrodeo

The Giveaway is an independent promotion by the Organizer. It is not organized, sponsored or endorsed by Red Bull GmbH or the Organizers of the Event. All trademarks remain the property of their respective owners and are used here for descriptive purposes only.

11. Liability

Attendance at the **Event** is at the winner's **own risk** and subject to the terms of the organizer of the Event .

The Organizer assumes no liability for technical malfunctions, loss of data or interruptions of the Instagram platform, nor for damages occurring during travel to or attendance at the Event. Notwithstanding that, the Organizer is liable only for damages caused by intent or gross negligence, as well as for damages resulting from injury to life, body or health. Liability for slight negligence is excluded insofar as no material contractual obligations are affected.

12. Final Provisions

These Terms & Conditions are governed by the laws of the Republic of Austria, excluding its conflict-of-laws rules and the UN Convention on Contracts for the International Sale of Goods (CISG). Mandatory consumer protection provisions of the participant's country of residence remain unaffected.

Place of jurisdiction – to the extent legally permissible – is the competent court in Austria. Should individual provisions of these terms & conditions be or become invalid, the validity of the remaining provisions shall remain unaffected. The invalid provision shall be replaced by a valid one that comes closest to the economic purpose of the invalid provision.
